


Pánă în acest moment am primit 3540 de chestionare completate, între care:

Subject of negotiation	Employers' association offer	FSAB demand	Comments
Gross minimum monthly wage in the sector	2100	2600	Under negotiation
Overtime pay	75%	100%	Under negotiation
Extra pay for working on public holidays	100%	100%	Agreed
Extra pay for working on weekends	15%	30%	Under negotiation
Compensatory salaries in the event of dismissal	-minimum 50% of one monthly wage - actual amount to be establish at company level	- minimum 50% of the last gross wage, for each year worked in the company	Under negotiation
Retirement bonus	<ul> <li>minimum 50% of one</li> <li>monthly wage</li> <li>actual amount to be establish</li> <li>at company level</li> </ul>
